Report on the implementation subject: testing, anti-graying liquid 200 ml cosmetic - sample number - 720-2017-00066816 (order no EUPLMA-00030843), Eurofins Polska Sp. z o. o., Al. Wojska Polskiego 90A, 82-200 Malbork, patch test.

1. Anti-graying liquid, 20ml cosmetics - sample number - 720-2017-00066816 (order no. EUPLMA-00030843).

Patch test: it was performed in 25 dermatological patients (volunteers): i.e. 15 women aged 19-55 and 10 men aged 19-55 years, in accordance with the Helsinki Declaration with subsequent supplements, EU regulations, the Republic of Poland and Cosmetics Europe guidelines. Patches were applied on the inner surface of the forearm according to the following method: 1 x 1 cm, the place is covered with 2 x 2 cm filter paper, then 2 x 2 cm tissue paper and 2 × 2 inch film and adhesive. After 24 hours the dressing was removed and the test result was evaluated. Re-checks were made at 3, 4 and 5 days of the study. The test was conducted from 25.05.2017 to 01.06.2017. The assessment of the reactions was performed according to a general scale in dermatological studies. The results are shown in Table 1.

The description of the substance and the expected activity is declared by the Ordering Party.

GR-7 is a liquid that restores the natural color and tone of the hair. It penetrates into hair bulbs stimulating the production of melanin, natural dye. The fluid is used to stop graying and to obtain a permanent effect - to restore and then maintain the hair in a natural color. Efficacy confirmed by laboratory tests of technology specialists. Fluid effects are dependent on the structure and condition of the hair. GR-7 works gradually, does not cause sudden changes.

2. Directions for use

The following directions for use are presented by the Ordering Party:

GR-7 should be used at least once a day (for faster results you can use it in the morning and evening). You may notice changes after 7 days of use.

- Always shake the bottle before each use to mix the contents. The liquid should be rubbed into the dried scalp (not in the hair!).
- It is recommended not to wash the head for the first 7 days of GR-7 use. Return to natural hair color can last from 7 to 21 days depending on individual structure and hair condition. To maintain the effect, use liquid at least once a week. Immediately after use you can not dry and wash your hair.
- Liquid should not be used on face, eyelash and eyebrows. If it gets into your eyes you should wash them well with water.
- During the course of treatment, it is advisable to reduce the consumption of coffee, alcohol, and cigarette smoking.
- For dyed hair, wait for 2 cm of growth.

Do not use the product if you are hypersensitive or allergic to any of the ingredients of theliquid.

3. Methodology of research

The usage - application test was done using the home-based method on an user group consisting of 25 persons.

25 volunteers, 15 women and 10 men aged 19-56 years were selected for the tests.

Users received one pack of the substance and recommendations for use consistent with indications of the Ordering Party.

Users received a survey to be completed after the application study.

They also undertook regular use of the product and declared that they would not use other products of identical or similar effect.

The anti - graying liquid was used 1-2 times daily as recommended by the manufacturer.

The application period was one month. All persons were dermatologically controlled two times a week.

Users were required to report any occurrence of skin irritation and in such case immediate withdrawal of the usage of the substance was recommended. The application - usage test was conducted under the supervision of a dermatologist.

- the product is well tolerated by the skin.
